

ORDINANCE NO. 2023-10

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BLUFFDALE, UTAH, AMENDING BLUFFDALE CITY CODE TITLE 2 (BOARDS AND COMMISSIONS) AND PROVIDING FOR THE CREATION OF THE HEALTHY BLUFFDALE COALITION BOARD

WHEREAS, Utah Code § 10-9a-102 grants the City of Bluffdale (the City") authority to enact ordinances that the Bluffdale City Council (the "City Council") considers necessary or appropriate for the health, safety, and welfare of the City; and

WHEREAS, the City has received a grant from the Salt Lake County Health Department that will provide funding for the City to develop a strategic planning framework to generate, investigate, and evaluate public health projects and initiatives; and

WHEREAS, the City Council finds that creation of a board and appointment of board members will facilitate the development of the strategic planning framework and the advancement of public health and wellness in the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BLUFFDALE, UTAH:


SECTION 1. Amendment. Bluffdale City Code is hereby *amended* as shown on Exhibit A.

SECTION 2. Severability. If any section, part, or provision of this Ordinance is held invalid or unenforceable, such invalidity or unenforceability shall not affect any other portion of this Ordinance and all sections, parts, provisions and words of this Ordinance shall be severable.

SECTION 3. Effective Date. This Ordinance shall become effective immediately upon publication or posting as required by law.
